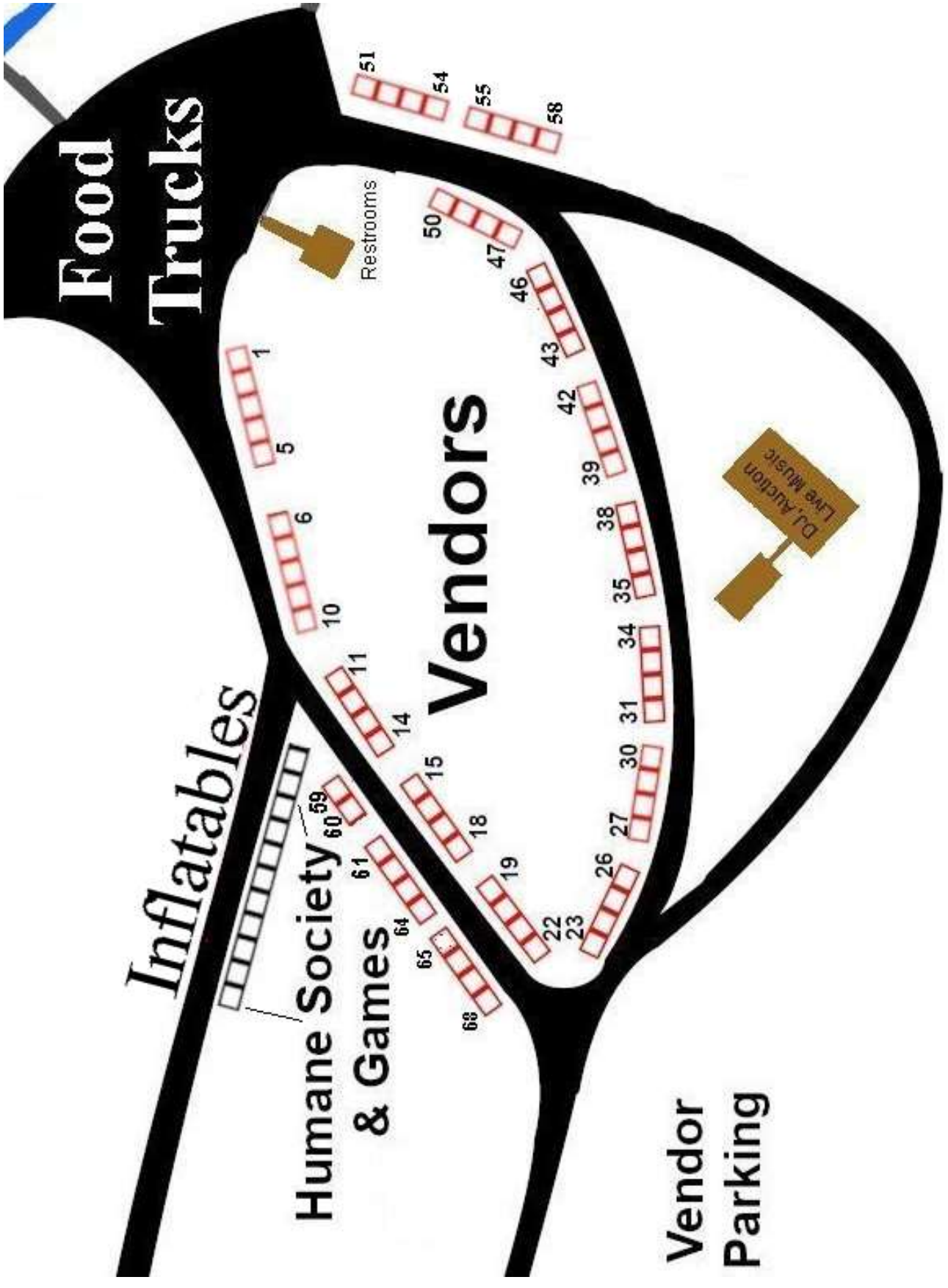

VENDOR GUIDELINES AND APPLICATION

TIMES AND LOCATION

The Howloween event will be held Saturday, October 26 2024 at Ollie Park in Clanton Alabama. This location is on Ollie Avenue next to the Clanton YMCA. The event will begin at 11:00 a.m. and end at 5:00 p.m.

ENTRY

Acceptance of your application and payment is required for participation. Vendors are strictly prohibited from reselling booth space. In the event that the vendor listed on this application is unable to attend, the booth space will be returned to the Humane Society of Chilton County.

Entry fees for booth spaces are \$50 for regular 10 x 10 booths and \$100 for food trucks. Entry fees must be submitted with your application by October 1, 2024. Cancellations with a refund will be accepted until September 1, 2024. **NO REFUNDS WILL BE GIVEN FOR ANY VENDOR AFTER September 2, 2023.**

Vendors are prohibited from distributing any items for free that are also sold by other vendors, including water, soft drinks, and edible items. If the Humane Society of Chilton County board of directors determines that a booth or activity is unsuitable for the Howloween event, they will request its removal. The Humane Society of Chilton County is not accountable for the sales or lack thereof of any booth space.

EQUIPMENT

Vendors must supply all needed equipment including tents, tables, chairs, generators, etc

SET UP

Set up will begin at 6:30 a.m. and vendors must be fully set up by 10:30 a.m. at the latest. Cancellation of the Howloween event due to inclement weather will be announced, if possible, by noon on October 25, 2024. No refunds will be given. After 10:00 a.m. vendor vehicles must be parked in the vendor parking area, you will be able to unload your vehicle at your vendor spot first. **YOU WILL BE RESPONSIBLE FOR ALL YOU OWN LOADING/UNLOADING AND ALL BOOTH SETUP.**

CLEAN UP

All vendors must be packed and off venue grounds by 7:00 p.m. Please clean up after yourself!

PARKING

One vendor parking space per booth space rented.

FOOD VENDORS

Food vendors are responsible for any health department permits or licenses required. If you do not have a permit for Clanton you can contact Mayor Mims office at 205-755-8486 and they will help you get an exception.

BOOTH SPACE

Booth spaces are 10 X 10, should you require additional room you will be required to purchase an additional booth space.

SAFETY

Tents are **required** to be staked down. Remove or mark any walking hazards.

PROMOTION

The Humane Society of Chilton County will advertise the event over a period of several months in local newspapers, radio, online as well as signage.
